#### **Background**

The educational planners need comprehensive, reliable, up-to-date, and timely data for decision-making purposes, related to planning, monitoring, evaluation and review of education system. Such education related data collection and representation occurs at all levels, from grass root level to higher education level.

The annual statistics reports/booklets are the most common form of information dissemination all around the world. They are the primary source of evaluating the health of an education system. These reports provide the basis for majority of government planning, decision-making and interventions. The donors also plan their support and interventions based on these reports.

The statistics unit in Strategic Monitoring and Evaluation (SM&E) directorate of Ministry of Education (MoE) is tasked with collection, collation, processing, analysis, and dissemination of education sector data.

Effective dissemination of education data is a key responsibility of the statistics units. In this regard the unit has been publishing Annual Education Statistics report (statistical yearbook). In addition to the statistical yearbook, the other dissemination mediums are: (i) publishing selected statistics on MoE website and (ii) through the web based information system called School Management Information System (SMIS). Additional, on demand, reports are also produced for the management of MoE.

However, two major issue related to statistical yearbooks have been identified, which are: (i) the production of report is not a regular feature, in the recent past the report is produced only in some of the years; and (ii) The timeframe for production of report needs to be improved so that the education managers can access the required information as early as possible. Therefore, a need has been felt to streamline the information dissemination mechanism in the statistics unit. This plan document is an effort towards such streamlining.

#### **Activities**

The plan covers four major activities for information dissemination, these four activities along with their respective sub-activities are as below:

- (1) Production and dissemination of statistical yearbook
  - Finalization of Template for yearbook
  - Acquiring demographic statistics / projections
  - Availability of statistical data from Annual School Census (ASC)
  - Analysis of data, calculation of indicators, trend analysis etc.
  - Finalization of draft statistical yearbook
  - Review by Management / stakeholders

- Finalization of yearbook
- Compilation of list of recipients / stakeholders
- Distributions of yearbook
- (2) Publishing of selected data on MoE website
  - Extraction of selected data for preparation of tables / graphs / charts as per publishing requirements of MoE website
  - Publishing of selected data on MoE website
- (3) Preparation and dissemination of summary statistical bulletins
  - Finalization of summary statistical Bulletins' formats and templates
  - Extraction of selected data from SMIS
  - Finalization of draft Bulletin
  - Review by Management / stakeholders
  - Finalization of Bulletin
  - Printing of Bulletin
  - Compilation of list of recipients / stakeholders
  - Distribution of Bulletin
- (4) Production and dissemination of provincial statistical yearbooks (for each of the 35 provinces)
  - To be carried out for 35 provinces, the activities are the same as national yearbook (No.1 above)
  - The activities will take place, in the same time frame, in parallel to the activities for national yearbook
